090/19 POLICE MATTERS - INCLUDING CRIME FIGURES AND REPORT FROM POLICE, IF IN ATTENDANCE

The Police Report for June was circulated to members. The Crime Update is as follows: -

In June 2019 a total of 34 incidents reported for Sileby to last month's 26. The incidents include 6 reports of criminal damage which is just lower from last month's 6. Again, this month there has been 0 reports of Theft from Motor Vehicles, however Burglary Dwellings are significantly high at a total of 8 being reported this month, (included are 2 reports of theft of motor vehicles, where during the burglary dwellings car keys along with the cars were stolen). 1 report of a Burglary Non-Dwelling and again this month 2 reports of Theft of Motor Vehicles (included in the burglary dwelling figures). Reports for Theft are slightly higher from last month's 7 to this month's 8 reported, (majority are shop thefts). This month 10 reports compared to last month's 7 reports of assaults (mostly domestic related incidents). Another 1 report of robbery this month which is being investigated at this time. On the plus side there were 7 stop & searches by officers in Sileby and an incident where 1x male & 1x female were arrested for possession of drugs and an amount of cash.

094/19 TO RECEIVE REPORTS FROM COUNTY AND BOROUGH COUNCILLORS

County Councillor Mr R Shepherd reported that he had attended the No 27 Bus Consultation on Friday, 12 July and brought some 'Engagement Packs' for members. He has prepared his next 'blog' and he will forward it to the Deputy Clerk for publication on the website www.silebyparishcouncil.org.uk.

Borough Councillor Mr P Murphy reported that all new Borough Councillor Induction Training is now complete and all councillors have completed training required. He has had a few residents with issues which he has now resolved. He reported that Councillor Mrs E Astill has asked him to 'call in' planning application P/19/1215/2; the reason being that this is a sizeable scheme of 195 dwellings where the original density of development has been substantially

altered due to the reduced area of land designated suitable for development by the Planning Inspector. Councillor Murphy confirmed that he had left a message for the Planning Officer concerned, and will follow this up when he returns to the office on Monday, 22 July.

095/19 TO RECEIVE REPORTS ON MEETINGS ATTENDED OR REPORTS RECEIVED – FOR INFORMATION ONLY

Councillors Mrs E Astill and Mrs E Jones met with the Maintenance Technician at the Memorial Park to inspect the surfaces in the children's play area; they are meeting Doug Bellfield from Streetscape on Friday, 19 July to discuss a solution.

Following on from their Support Day meeting with the Football Foundation and the County FA, Councillors Mrs E Astill, Mrs J Jones and Mr B Richards had a further meeting with Sileby Juniors Football Club. They feel it is the start of a good relationship with Sileby Juniors ad plan to meet on a regular basis.

Councillor Mrs E Astill had an informal meeting with three residents who live on the Miller Estate – this was to find out the issues they have experienced with the Miller Estate; they have joined a Homeowners Rights Network (HorNet) - this is a national problem.

- (a) P/19/1210/2 Proposed single storey extension to rear and two storey rear and side extension to dwelling 22 Ratcliffe Road, Sileby, LE12 7PZ
 RESOLVED No objection
- (b) P/19/1319/2 Variation of condition 2 of P/18/0399/2 to extend the operational life of the solar farm until 2057 Gypsum Solar Farm, Barrow Road, Sileby, LE12 7LR RESOLVED To object to the extension beyond the 25 years as we consider the Case Officer's initial concern for the application P/18/0399/2 that there were likely to be some negative landscape impact from the proposal as it would introduce some development in the lower valley slopes. Now that the site is being constructed it is very obvious there is a negative landscape impact and this extends beyond the immediate vicinity and impacts widely on the landscape character of the Soar Valley. For this reason, we consider the initial limit of 25 years should remain and there is no material planning benefit to extend it to 40 years.
- (c) P/19/1215/2 Erection of 195 dwellings including public open space, landscaping, access and surface water attenuation, Land to the east of Seagrave Road, Sileby RESOLVED To note that on Wednesday, 17 July Councillors Mrs E Astill, Mrs J Jones and Mrs E Jones had a meeting with two planners from Miller Homes. Various issues were discussed and concerns were raised which need to be addressed. The two planners said they would get back to us and the Planning Working Group will then meet up.

097/19 BARNARDS DRIVE APPEAL - UPDATE ANY ACTION WHICH NEEDS TO BE TAKEN

P/18/0659/2 Outline planning application for up to 228 dwellings with associated infrastructure, landscaping, open space and associated works. Access from Barnards Drive and pedestrian/cycle/emergency link from Parsons Drive. (All matters reserved except for the consideration of access). Land off Barnards Drive, Sileby Planning Inspectorate Reference: **APP/X2410/W/19/3220699** Gladman Developments Ltd - Councillor Mrs E Astill urged members to look on Charnwood Borough Council's website under the Appeals Section. The Inquiry into the Appeal will take place on Tuesday, 6 August 2019 at 10.00 am at the Ramada

Hotel, High Street, Loughborough and is scheduled to last 4 days. It is important that people attend this Inquiry.

This application proposed to create a playing field including sports pitch with boundary fence, footpath link and drainage — site for the erection of 135 dwellings land off Seagrave Road. Councillor Mrs E Astill has spoken to the Business Manager of Highgate Primary School as she needs help and support in getting the facilities, as stated in the S106 contributions document, they are entitled to. Councillor Mrs Astill proposed a Working Party is set up to support Highgate and it was **RESOLVED** to agree to this request and Councillors Mr B Richards, Mrs J Jones, Mrs E Jones and Mrs E Astill be on the Working Party. As a few members were absent it was **RESOLVED** to ask them if they wished to attend.
