"I continue to be in contact with Councillor McRae and Borough Councillor Lawrence about issues concerning flooding and planning enforcement.

I have no matters of concern to Sileby in particular to report at the moment. I continue to circulate information items of County-wide interest and am grateful to the Clerk for forwarding them to Councillors.

Please let me know of any matters which the Parish Council would like me to follow up or about which more information is needed."

Councillor R Butler asked if Councillor Shepherd could chase his complaint regarding the road surface at the Burton Road roundabout. The Clerk offered to chase this complaint, and Councillor Butler will forward details of the complaint to the Parish Council office.

Borough Councillor G Lawrence gave his report on behalf of Borough Councillors.

National Planning Policy Framework

The Government has announced significant changes to this national framework that will impact on future planning decisions by the local planning authority:

- Reintroduction of mandatory housing targets and changes to the way those targets are calculated
- Changes to the Right to Buy scheme with increased ability for councils to use the receipts from council house sales to build & buy new social homes.
- National scheme of delegation to local planning committees to replace local schemes the provisional view of Charnwood Borough Council is that this is likely to reduce the number of small planning applications that are considered by the Plans Committee.

There is a consultation period underway on the NPPR changes that ends on 24th September. Charnwood Borough Council's current understanding is that these changes will not impact on the expected timescale for the adoption of the new Charnwood Local Development Plan, i.e. late-2024.

Peashill Farm walkway to Ratcliffe Road

It has been reported to us that 1 or 2 cars have used the walkway as a short-cut from Ratcliffe Gardens estate to Ratcliffe Road. I have informed Planning Enforcement and they have again written to Davidsons to request urgent completion of the installation of bollards & removable barriers at the bottom end of the walkway.

Charnwood Grant for Sileby

The Joy of Music (Sileby) community group operating the weekly support group for people experiencing low-level mental health challenges have secured a £4,000 grant from Charnwood Borough Council. This will enable them to put the service on a firm footing, and to promote the service more widely than previously. The music-based therapeutic sessions will start again after a summer break on Tuesday 20th August at 10.30am at Sileby Methodist Church.

Councillor J Jones gave members an update on the site meeting that was held on Thursday, 25th July 2024 with councillors, a representative from Severn Trent and Toby Jesson from the EA. Severn Trent has agreed to carry out a site survey on their land above the park and will email the Parish Council office with an update, when available.

A Flood Working Group had just taken place prior to the Parish Council meeting, which included Parish Councillors, Toby Jesson (EA) Richard Oldham (Flood Warden) and Borough Councillor Geoff Lawrence. Summary of discussions:

- Awaiting a report from Severn Trent regarding their overgrown land above the park (Gibson Road area up to Heathcote Drive). They are also going to check if the pipes are operational and working correctly as they should. To also see a copy of their maintenance plan.
- Clerk to email Charnwood Borough Council Planning, and ask the following questions:
 - Are the balancing ponds signed off by a Building Inspector?
 - Who monitors the balancing ponds?
 - Who owns and maintains the balancing ponds?
 - What enforcement is in place if the balancing ponds are ineffective and not working properly?
- The Environment Agency is scheduled to clear silt and vegetation in 2024.
- A lengthy discussion took place regarding the potential siting of a 'Trash Rack' at the bridge on the Memorial Park. It was agreed that the reality versus risk does not make the track rack feasible.
- Toby Jesson informed members what the Parish Council's obligations are regarding Riparian Rights and Sileby Brook.

A Project Park! meeting had taken place earlier in the week with Cara Baker (CBC). This will be covered later under minute no's 105/24 and 115/24.

Councillor M Wilson-Knight has reported issues to the Canal and Riverside Trust regarding trees obstructing the Right of Way on the towpath between Sileby and Cossington lock,
