The Clerk read out County Councillor Mr R Shepherd's report: -

"I am in contact with Councillor McRae and Borough Councillor Lawrence about matters concerning Cygnet Close.

Some time ago a resident raised with Borough Councillor Bottomley a concern about water on the surface of Ratcliffe Road, and BC Bottomley contacted me about it. I in turn raised this matter with County Council officers. An exploratory dig down and investigation subsequently took place, in January. The most recent information I have received from an officer, dated 27th June, is that in the investigation "...the operatives couldn't find any issues. All they were able to witness is the open excavation would fill with water. This will now be added to the agenda for our partnership meeting with Severn Trent Water." The officer is aware that this is a long-standing issue. I have forwarded the most recent information to the resident and copied in the Borough Ward Councillors.

I continue to be grateful to the Clerk for kindly forwarding County Council media releases and other items of information to Parish Councillors.

Please let me know if there are any matters which Parish Councillors would like me to follow up or about which more information is needed."

TO RECEIVE AN UPDATE FROM THE PROJECT PARK! WORKING PARTY

Councillors J Jones, A Higgs, E Jones and N Matlock met with Ground Control to discuss the planting in the Park Entrance. It was noted and agreed that some plants/trees have failed, or are failing, due to various reasons.

Ground Control confirmed that any failed plants/trees would be replaced as part of the ongoing maintenance contract at an appropriate time. (excludes vandalised stock). It was agreed that Ground Control would meet again with Sileby Parish Council in September to do a stock take on the progress of the plants and the replacement programme. The Working Party recommend that payment is made in full. Ground Control agreed to invoice the maintenance contract in thirds to allow space to withhold payment should any issues arise with the plant replacement plans. (3 payments of £2754.01).

Councillors J Jones, A Higgs and J Walker met on 29 June at the Memorial Park with volunteers (only two volunteers turned up) to discuss the Community Garden project. Councillor Jones informed them that they would have to form a committee and open a bank account and that they need numbers to make it work. It was suggested that a WhatsApp Group is set up so making it easier to communicate; a further meeting is to be arranged.
