The Deputy Clerk read County Councillor Shepherd's reports, as follows: -

Matters of particular interest to Sileby:

A member of the public has sent me an email headed "Prevention of access to flooded highways".

Please see below an edited version of the email, edited in that I have removed the sender's name and personal details.

Edited version:

"Over the last few years, instances of flooding have become more frequent that I think we can all agree.

Although we have an excellent team of volunteers dedicated to monitoring the flooding to the highways and placing signs, cones etc. There is still an element who either ignores the warnings or who in acts of vandalism remove the warning.

This has, and no doubt will in the future, led to vehicles becoming stranded and requiring the limited resources of the rescue services to get them to safety.

I can see that in Barrow-on-Soar electronic signs have been erected, all well and good for those Barrow residents but not for those living in Sileby, East Goscote, Cossington or Ratcliffe.

Is it not time the developers of the new housing estates in these villages were forced to pay for a more robust warning system, by installing swinging lockable gates across the likes of Slash Lane, Broom Lane, Mountsorrel Lane, Syston Road to stop any vehicle access. Like the snow gates on the A66.

Surely such a cheap and easy fix would stop any vehicle entering the flooded highway thereby preventing any loss of life through an accident."

Councillor J Jones requested an update on the transport budget that LCC had received, and the extra allocation of monies towards transport.

The Council also asked the Clerk to pass on their good wishes to Councillor Shepherd.

Borough Councillor Forde gave an update and information on:

- 1. Flood Drop-in sessions next session is at Syston Community Centre on Wednesday 20 March, 2pm to 7pm
- 2. Cemetery Road Development balancing pond issue still in dispute
- 3. Cossington Road Development developers dispute ownership of the ditch that needs clearing, but agreed to clear. This has been done, but it has been requested that they come back and remove the silt, which is the issue.
- 4. An update was given on the Charnwood Borough Council Local Plan.
- 5. An Action Group has been formed to campaign to get the A46 Seagrave junction made safer. Councillor N Matlock agreed to attend the next meeting. Councillor Forde to email Councillor Matlock further information. Councillor Wilson-Knight suggested obtaining a FOI asking for the number of accidents that have occurred on that junction.

Councillor McRae informed Councillor Forde that he is having issues with Charnwood Borough Council in his role in trying to assist residents on Ratcliffe Road with issues with their Council properties, that have been impacted by the Peashill Development. It was agreed that Councillor McRae would email Councillor Forde the information for her to look into this matter.

Councillor Higgs asked if any action was going to be taken against the company whose lorries are going along Swan Street to the Homefield Road development, which is not the designated route. The Deputy Clerk had reported this to Planning Enforcement, but had not had an acknowledgement or response. Councillor Forde said that they had also reported it to

Enforcement. Councillor Higgs felt that 'Enforcement' should enforce, as they are still using the route.

Councillor N Matlock reported that the road at the top of Cemetery Road has still not been resurfaced, despite this should have been done last November. This would be another enforcement issue.

The Chairman reported on the virtual meeting with Cara Baker and Red Kite, which took place on Tuesday, 5 March. Entrance Planting was discussed and a practical completion date is to take place on Monday, 11 March with Red Kite, Ground Control and Councillor Higgs. Play equipment was discussed and Red Kite will require specific choices of play equipment. Councillor Higgs provided responses from consultation. Red Kite to look into other play areas that have impressed consultees and the working group. Benches and bins were discussed and it was agreed that they will be galvanised steel with no paint finish so a silver/grey colour. The bollards and solar lighting were discussed and was the bound gravel surface. Also discussed was the Edible Garden Layout; its potential for conversion into a sensory garden was noted as well as the possibility that it could be expanded with an outer row of raised beds, if needed.
